The following guidelines were set in the online meeting with the consent of all the faculty members and the representative of Department of Commerce, Delhi School of Economics, University of Delhi.

UNIT I

With regard to Unit 1, the following suggestions were made:

- 1) A general overview of international trade and investment opportunities should be discussed with the students.
- 2) Impact of Covid-19 pandemic on International Business Environment (such as rising protectionism) with examples should be discussed with students.

UNIT II

With regard to Unit 2, the following suggestions were made:

- 1) Recent updates on tariff and non-tariff barriers and BOP accounts should be discussed with students.
- 2) Recent data and information on regional economic integration can be referred to and shared with students.

UNIT III

With regard to Unit 3, the following suggestions were made:

- 1) Provide awareness related to the latest trends in currencies markets.
- 2) Conceptual clarity should be imparted on topics mentioned under this unit.
- 3) No numerical will be asked from this unit.

UNIT IV

With regard to Unit 4, the following suggestions were made:

- 1) Concept clarity may be provided through contemporary examples, wherever applicable.

UNIT V

With regard to Unit 5, the following suggestions were made:

- 1) Latest trends in FDI should be shared with the students. The changes in government policy with regard to FDI, SEZs and EOUs should also be discussed in the class.

In general, students who support their answers with contemporary examples should be incentivised during evaluation.

All the faculty members participated actively in the discussion and agreed to the above mentioned guidelines. The meeting ended with thank you notes.
